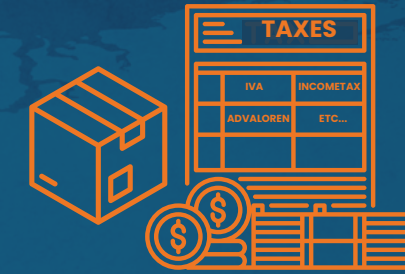

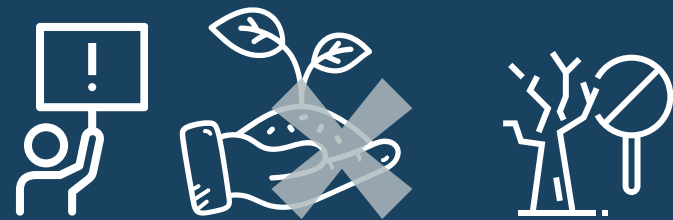
Firearms, ammunition, explosives and chemical, flammable and suffocating substances

Radio communications equipment. They require prior authorization to use the transmission band



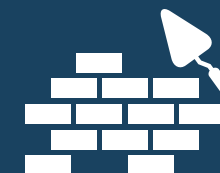
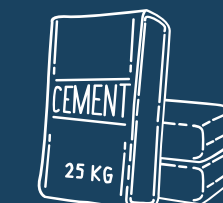
Human remains or incineration ashes of the same
